Direction governing registration as registered graduates and enrollment in the Electoral Roll of Registered Graduates of North Maharashtra University, Jalgaon.

WHEREAS, term of office of members of every authority and/or body constituted under the provision of sub-section 1 of Section 42 of the Maharashtra Universities Act, 1994 is expired and/or ceased on 31st August, 2015.

AND

WHEREAS, taking into consideration the provision stated under sub-section 3 and sub-section 5 of Section 99 r/w sub-section 2 (r) of Section 25 of the Maharashtra Universities Act, 1994, this University promulgated Public Notice on 13.03.2015 with a request to graduates to apply or enroll themselves as a registered graduates of this University.

AND

WHEREAS, accordingly this University received number of applications alongwith prescribed fees from the graduates of various faculties of this University for register themselves as a registered graduates in view of said Public Notice.

AND

WHEREAS, in view of temporary postponement of election of the authorities and bodies of the non-agricultural and non-technological Universities in the State of Maharashtra and vide Maharashtra Government Gazette, dated 17.08.2015, Government of Maharashtra promulgated "Temporary Postponement of Election of the members of the University authorities and other bodies of the Universities" and adopted the policy that no elections will be held in the Universities till 31st August, 2016.

AND

WHEREAS, in exercise of powers conferred by sub-section 2 of Section 1 of The Maharashtra Public Universities Act, 2016 (hereinafter referred to as "said Act") Government of Maharashtra Published "said Act" in the Maharashtra Government Gazette on 11th January, 2017 which came into force w.e.f. 1st March, 2017 by repelling the Maharashtra Universities Act, 1994.

AND

WHEREAS, Section 131 of the Maharashtra Public Universities Act, 2016, provides the provision relating to the eligibility of the persons who are entitled to have their names entered in the register of registered graduates or deemed to be a registered graduate, maintained by this University.

AND

WHEREAS, sub-section 3 of Section 131 of the Maharashtra Public Universities Act, 2016, provides the scheme and procedure in respect of a person who intends to be a registered graduate as per the provisions prescribed by the Statute in that respect.

AND

WHEREAS, as per the scheme prescribed under sub-section 2 (k) of Section 147 of the Maharashtra Public Universities Act, 2016, University has to maintain the "Register" of the registered graduates, whose names were entered in the register of registered graduates maintained by this University immediately before the commencement of the "said Act".

AND

WHEREAS, as per sub-section 2 (k) of Section 147 of the Maharashtra Public Universities Act, 2016, the persons whose names were entered in the register of registered graduates maintained by the University shall be deemed to be the registered graduates of this University for the purpose of this Act and are continued to be the registered graduates of this University.

AND

WHEREAS, Department of Higher and Technical Education, Mantralaya, Mumbai issued a notification in respect of uniform Statute No.2 of 2017 on 17th May, 2017 prescribing a detailed procedure for registering registered graduates specifying that all persons whose names were entered in the register of registered graduates shall be entitled to register their names in the electoral roll of registered graduates.

AND

WHEREAS, no specific provisions are made under the said Statute or in the "said Act" regarding the bonafide actions taken by this University in the transitory period in respect of applications which are already received to this University vide Public Notice dated 13.03.2015.

AND

WHEREAS, in absence of specific provisions under the "said Act" as well as the Statute made thereunder regarding consideration of these applications which are already received to this University vide Notification dated 13.03.2015 for registering the registered graduates for the electoral roll for the purpose of election of registered graduates of this University which is required to be taken under the provisions of the "said Act".

In view of above situation, facts and circumstances, it is a need of time to regulate the above issue as per the provision of law and since there is no Statute in that respect, hence, only with an object to protect the interest of those persons who have already applied to enroll themselves as registered graduates of this University vide Public Notice dated 13.03.2015;

I, Prof. Pradip Premchand Patil, Vice-Chancellor of North Maharashtra University, Jalgaon as per powers vested to me under sub-section 8 of Section 12 of the "said Act", do hereby issue a Direction that, all the applications which were received by this University vide Public Notice No.NMU/2/Election/08/2015, dated 13.03.2015 in respect of registration of registered graduates are found to be eligible after its due scrutiny and names of all eligible graduates are registered in the register of registered graduates maintained by this University as well as applications of those registered graduates which are found to be eligible shall be treated as valid applications for the enrollment in the electoral roll required to be prepared by the University under clause (5) of sub-section 2 of Section 131 of the "said Act".

The said Direction shall come into force with immediate effect.
