Notice of Election to Elect Representatives from Academic Council to Management Council

**[As per Section 30 (4)(j)
of the Maharashtra Public Universities Act, 2016]**

As approved by the Hon'ble Vice-Chancellor, it is notified for information of all concerned that the election to elect representatives from Academic Council to Management Council under clauses (j) of sub section 4 of section 30 of the Maharashtra Public Universities Act, 2016 will be held on **Tuesday, the 29th May, 2018**. The detailed programme of the election has already been published vide Notification No.ELECT-22/2018 and letter Ref.No. NMU/E.P./2/243/2018 dated 08.05.2018. The same is again reproduced below :-

Important Instructions :

- 1] As per Maharashtra Public Universities Act, 2016 regarding representation of Academic Council to Management Council is as given below:

Clause No.	Provision	Allocation of Seats
30(4)(j)	Two members elected by the Academic Council from amongst its members, one of whom shall be from amongst the elected teachers who are members of the Council and another shall be a woman;	1- Elected Teacher 1- Woman

- 2] The candidate should follow the instructions, as given in Uniform Statute 01 of 2017, published by Higher and Technical Education Department, vide its Notification, dated 17th May, 2017 and Notification dated 28th April, 2017.
- 3] Election shall be conducted as per amendment suggested by Government of Maharashtra vide Ordinance no. XXVIII of 2017 dated 26th November, 2017 and Government of Maharashtra vide Ordinance no. I of 2018 dated 20th January, 2018.
- 4] A copy of **Nomination Form** is attached herewith as **Annexure-I**. The candidate should download the nomination form from Election Portal of NMU website [www.nmu.ac.in] and fill in the nomination form manually and submit a hard copy of the nomination form, duly signed, alongwith requisite documents within the stipulated time limit.
- 5] The detailed procedure and necessary instructions about filling of the Nomination Form and other relevant instructions are included in the nomination form.
- 6] If a candidate is not satisfied with the decision of Registrar and Returning Officer regarding validity of nomination form, he can prefer an appeal to the Hon'ble Vice-Chancellor up to 13.30 pm on 22.05.2018 after declaration of valid and invalid list.
- 7] The candidate will have to pay Rs.500/- as non-refundable nomination fees alongwith nomination form within stipulated time limit. The fees should be paid by Demand Draft of any Nationalized Bank, drawn in favour of Finance & Accounts Officer, N.M.U., Jalgaon or in cash to the cash counter of the university at the time of submission of nomination form.

- 8] The voter shall have to vote at the specified place in the meeting hall fixed by the university only.
- 9] The list of members of Academic Council will be published on 17th May, 2018.
- 10] The candidate/proposer/seconder should be a member of Academic Council.

Notes:-

- 1] The programme stands final in the light of provisions of the Act, Statutes and Directions issued by the Government of Maharashtra and North Maharashtra University, Jalgaon from time to time.
- 2] All activities regarding Election will be entertained within office hours only except and otherwise mentioned.
