Important Instructions to the candidates:-

- 1] If a candidate is not satisfied with the decision of Registrar & Returning Officer regarding validity of nomination form, he can prefer an appeal to the Hon'ble Vice-Chancellor up to 02.00 p.m. on 27.08.2017 after declaration of valid and invalid list.
- 2] The candidate will have to pay Rs.500/- as non-refundable nomination fees alongwith nomination form within stipulated time limit. The fees should be paid by Demand Draft of any nationalized bank, drawn in favour of Finance & Accounts Officer, N.M.U., Jalgaon or in cash to the cash counter of university.
- 3] As per University Direction bearing No. 10/2017 regarding representation of Management Representatives on Senate, the allocation of **Six Seats** is given below:-

a) Unreserved	:- 04
b) Reserved for Scheduled Caste <u>[by rotation]</u>	:- 01
c) Reserved for Woman	:- 01
- 4] The candidate should follow the instructions, as given in the relevant Directions of Hon'ble Vice-Chancellor, which were already communicated to all the Affiliated Colleges/ Recognized Institutes, vide letter No.NMU/2/Election/45/2017, dated 22.07.2017.
- 5] The candidate should follow the instructions, as given in Uniform Statute 01 of 2017, published by Higher and Technical Education Department, vide its Notification, dated 17th May, 2017.
- 6] A copy of **Nomination Form** is attached herewith as **Annexure-1**. The candidate should download the nomination form from Election Portal of NMU website [www.nmu.ac.in] and fill in the nomination form manually and submit a hard copy of the nomination form, duly signed, alongwith enlisted documents within the stipulated time limit.
- 7] The detailed procedure and necessary instructions about filling of the Nomination Form, list of documents etc. and other are relevant instructions are included in the nomination form.
- 8] The rules for validity of nomination form will be published separately.
- 9] The format of Voting Paper is attached herewith as **Annexure-2**.
- 10] The **NAAC/ NBA certificate** of the Affiliated College/ Recognized Institute **should be valid up to the date of counting and declaration of result.**


