- (a) 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. /Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:



Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the

requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

Note:

- 1) The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for appointment of Assistant Professor in such disciplines.

OR

(b) The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS);

(ii) the Times Higher Education (THE) or

(iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

(A) for Sr. No. ASPUC-01: Computer Science/ Computer Application / Information Technology (Qualification as per AICTE Rules)

B. E. / B. Tech. / B. S. and M. E. / M. Tech. / M. S. or Integrated M. Tech. in relevant Branch with first class or equivalent in any one of the degrees.

OR

B.E., B. Tech and MCA with first class or Equivalent in any one of the degrees.

OR

Graduation of three years' duration with Mathematics as a compulsory subject and MCA with first class or equivalent with two years relevant experience after acquiring degree of MCA

(B) for Sr. No. ASPUC-03 : # Actuarial Science

M.Sc. (Actuarial Science) with first class or equivalent

OR

M.Sc. (Statistics) with at least 55% marks and NET/SET /Ph.D. (Statistics) (as per UGC rules) with Actuarial Science background.

(C) <u>for Sr. No. ASPUC-</u>10: Paint Technology/Plastic Technology, (Qualification as per AICTE Rules)

B. E. / B. Tech. / B. S. and M. E. / M. Tech. / M. S. or Integrated M. Tech. in relevant Branch with first class or equivalent in any one of the degrees.

(D) <u>for Sr. No. ASPUC-11 & 12:</u> MBA Finance/HRM/ Marketing/Operation/ Agribusiness & Management (Qualification as per AICTE Rules)

Bachelor's Degree in any discipline and Master's Degree in Business Administration /PGDM /C.A./ ICWA /M.Com with first or equivalent and Two years of Professional Experience after acquiring the Degree of Master's Degree.

(E) for Sr. No. ASPUC-16 & ASPUC-17: Yoga & Yoga Therapy (Qualification as per UGC Rules)

a.

1) Good academic record with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) at the Master's degree in Yoga or any other relevant subject, or an equivalent degree from an Indian/foreign University. 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

OR

b. A Master's degree in any discipline with at least 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) and a Ph.D. degree in Yoga* in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be.

***Note:** Considering the paucity of teachers in the newly-emerging field of Yoga, this alternative has been provided and shall be valid only for five years from the date of notification of these Rules.

NOTES:

- 1. A relaxation of 5% marks be provided (from 55% to 50% of the marks) to the Ph.D.Degree holders who have obtained their Master's Degree prior to 19th September, 1991.
- 2. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized University, at the Master's level shall also be considered valid.
- 3. A relaxation of 5% shall be allowed at the Bachelor's as well as the Masters' level for the candidates belonging to scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non creamy Layer) /Differently abled ((a) Blindness and low vision: (b) Deaf and Hard of hearing: (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy: (d) Autism, intellectual disability, specific learning disability and mental illness. Multiple disabilities from amongst person under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 4. 4% reservation will be observed for physically handicapped candidates as per Government Resolution dated 29.05.2019.
- 5. 30% Reservation for women shall be observed as per Government norms.
- Non-Creamy Layer Certificate for the candidate belonging to the DT-A, NT-B, NT-C, NT-D, OBC and SBC categories, as per Govt. of Maharashtra Resolution dated 16th December, 2017, issued by the competent authority valid till the date 31.03.2024.
- 7. The Reserved category candidate should submit their Cast Validity Certificate as per the Government Resolution, wherever applicable.
- 8. As per Government Resolution No.BCC-2016/PK 228A/16/16 B. dated 29th May, 2017. A/B/C/D/ points in VJ/NT Category are interchangeable.
- Weightage shall be given to the applicants who have published work of high quality and who have succeeded in bringing funds by submitting research projects to various funding agencies such as UGC/ CSIR/ DST/DBT/TWAS/ ISSR/AICTE etc.
- 10. Candidate belonging to specific reserved category from Maharashtra State alone shall be considered for reserved post and they are required to submit Caste Validity certificate at the time of joining.
- 11. Candidates from reserved category, who are domiciled outside the Maharashtra State will be treated as Open category candidates as per Govt. G.R. No. CBC-1290/23116/ pra.kra.378/avaka-5 dated 24.08.95.

Candidates having cleared State Eligibility Test (SET) from the State other than Maharashtra State shall not be considered for appointment.

- 13. As per provision contained in State Govt. Notification No. SRV.2000/ CR(17/2000)/XII dated 28th March, 2005, issued by General Administration Department, Mantralaya, Mumbai, candidates must submit the prescribed declaration of the small family as one of the essential qualifications for recruitment, the prescribed proforma is attached herewith as **Appendix B**.
- 14. The University Authority reserves its right, to fill up or not to fill up the posts, to modify/ alter/cancel the advertisement or change in number of posts.

Also, the University Authority reserves its right, to extend the services of the candidate for the next academic year, after assessing the performance of the candidate during the previous academic year. Vide Govt. Resolution dated 09.02.2018.

- 15 Criteria for Short-listing of Candidate for Interview for the contractual post of Assistant Professors in Universities will be as per Table 3A of the Government Resolution 8th March 2019.
- 16. Knowledge of Marathi Language is desirable for all posts.
- 17. Application fee of Rs.500/- (for open category) and Rs. 250/- (for candidates belongings to reserved category) should be paid by online mode only.
- 18. Applicants shall apply through online mode only from 22.08.2024 to 01.09.2024 through web site link of the university: https//apps.nmu.ac.in/recruitment/ Also candidates are informed to submit hard copy of online form along with testimonials in Two copies with online payment receipt. The last date of submission of hard copy of application is on or before 06.09.2024 upto 5.00 p.m.
- 19. A candidate furnishing incorrect or false information shall stand disqualified at any stage.

20 For the above posts retired persons who have not attained the age of 65 years may also apply.

- 21. Applicant who wishes to be considered for more than one post should apply separately for each post.
- 22. Mere possession of minimum qualifications does not confer any right to be called for interview and /or selection.
- 23. Applicants already employed should submit their hard copy of applications through proper channel.
- 24. Applications received after the last date and/or not submitted through proper channel and/ or incomplete application will not be considered.
- 25. The University will not be responsible for postal delay of the hard copy, if any.
- 26. Applicants will be required to attach the certificates of their date of birth, educational qualifications, caste certificate, non-creamy layer certificate, caste validity certificate (if obtained) experience, research experience etc.
- 27. Interview schedule, all updates, corrigendum (if any), any instructions regarding recruitment will be uploaded from time to time on the website of this University. Hence applicants are advised to visit University website regularly, the University will not entertain any inquiry regarding eligibility criteria.
- 28. List of candidates to be called for interview will be published on University website and no postal correspondence will be made in this regard.
- 29. Canvassing directly or indirectly will be treated as disqualification.
- 30. As these posts are purely temporary on contract basis, candidates appointed will not be entitled to claim for regular appointment.
