Technical, General and Commercial Conditions of the tender:

- 1) The tender for **SUPPLY OF BENCH TOP ORBITAL INCUBATOR SHAKER 01NOS.** from manufacturer authorized distributor and dealers.
- 2) **EARNEST MONEY DEPOSIT**: Vendors are required to submit a Demand Draft of Nationalized Bank of Rs. 8500/- (Rupees- Eight Thousand Five Hundred Only) as Earnest Money Deposit along with the tender. The Demand Draft must be drawn in favor of "**Finance and Accounts officer, K.B.C.N.M.U. Jalgaon".** In addition to Earnest Money Deposit Vendor is required to give a demand draft of Rs. 1700/- (Rupees One Thousand Seven Hundred only) towards the cost of tender (non-refundable) along with the tender. Offers made without E.M.D. & Cost of Tender will be rejected. If the tenderer, whose tender is accepted, refuses to accept the order, the amount of E.M.D. will be forfeited.
- 3) Copies of SSI / NSIC /MSME registration certificate. (In case of Exemption in payment of Tender Fees/EMD is claimed.) The related G.R./ circular must be uploaded
- 4) Payment : 100% payment after satisfactory supply and Installation within 30 days from the date of receipt of installation report.
- 5) <u>Delivery, Installation Period:</u> Two weeks from the date of receipt of purchase order.
- 6) <u>Terms of Delivery</u>: F.O.R. K.B.C.N.M.U., Jalgaon.
- 7) Rates mentioned in commercial bid must be inclusive of GST.
- 8) Tender offer must be valid for a period of 120 days after the date of opening of tender. Any offer failing short of the validity period is liable for rejection.
- 9) All disputes are subject to Jalgaon Jurisdiction.
- 10) **Security Deposit:** The successful tendered to whom the work/ supply / purchase order is given shall be required to deposit an amount equivalent to 5% of total value of work order (inclusive of all taxes, duties etc.) as security deposit within 7 days from the date of Purchase Order/work order. The security deposit will not carry any interest which shall be refunded after supply and successful completion of the work. If the bidder fails to keep the security deposit, then the second lowest quoted bidder will be issued the similar purchase order or the University withholds the total authority for the necessary action to be taken. The security deposit will be fortified if the supplier fails to execute the purchase order.

- 11) Tender is being called in two envelopes system. i.e. the technical bid and commercial bid. The technical bid comprises Part-I details of the tenderer, Part-II Technical bid and Part III general and commercial conditions of the tender The Commercial bids comprises Part IV. The tenderer has to submit both the bids in separate envelopes.
- 12) The Tenderer must submit his offer in two separate envelopes A-B envelope-A will contain part I, II, III and Envelope –B will contain part IV both the envelopes must be super cried as "TENDER FOR SUPPLY, INSTALLATION OF SUPPLY OF BENCH TOP ORBITAL INCUBATOR SHAKER (01NOS).
- 13) The University reserves the right to accept or reject any or all the tenders from any or all the parties without assigning reason thereof.
- 14) Tender offer should be complete in all respect and as per the format as prescribed by the university. Incomplete offers would not be entertained.
- 15) Copies of shop Act Registration, GST & PAN Card Registration etc. should be enclosed along with part-I
- The University reserves the right to delete/ increase/ decrease items from the schedule of requirement specified in the tender.
- 17) The University reserves the right to accept or reject all or any tender without assigning any reason whatsoever.
- 18) Tender received after due date and time will not be considered whatever may be the reason therefore. In case tender are sent by post / speed post courier etc.It shall be responsibility of the tenderer to ensure that they are received before due date and closing office hours.
- 19) The rates without any corrections or overwriting should be quoted for each individual item separately. Any overwriting or rewriting should be duly countersigned.
- 20) The decision of the University regarding this will be final and shall be binding on tenderer. The University reserve the right to accept or reject the entire tender.
- 21) The Venders black listed by the University are not eligible for submiting the tender. If they do so there tender will not be considered.
- 22) The last date for submission of tender shall be 09/01/2024.-up to 17.00 hrs.
- A printed original bill with GST has to be issued mentioning the University's GST No. 27AAAJNo465AIZL while submitting the payment. Proof of payment of GST amount in the bill will be required to be submitted to the State Government.
