7. The condition of suppliers with regard to the payment through Bank and condition of advance Payment will not be accepted in any circumstances. The payment will be made by cheque/RTGS only. Mention GST No.27AAAJN0465AIZL on Bill. Submit the copy of GST paid to the government along with bill.
