#### **Technical, General and Commercial Conditions of the Tender :**

- 1) The tender is called for TENDER DOCUMENTS FOR: - Rota Evaporator.
- 2) **EARNEST MONEY:-** Vendors are required to submit a online payment of **Rs. 18,000/- (Rupees- Eighteen Thousand Only)** as Earnest Money Deposit along with the tender. In addition to Earnest Money Deposit Vendor is required to pay online of **Rs.3,600/- (Rupees Three Thousand Six Hundred only)** towards the cost of tender (non- refundable) along with the tender. Offers made without E.M.D. & Cost of Tender will be rejected. If the tenderer, whose tender is accepted, refuses to accept the order, the amount of E.M.D. will be forfeited.

The Micro and Small-Scale enterprises registered with the National and state small industries corporation (NSIC/MSME) also must pay the amount of tender fees and earnest money. Please note that the tender will not be considered unless the said fee is paid by the suppliers.

Supplier can submit Demand Draft to the University, if facing technical issues during processing online payment of EMD & tender fees. Demand Draft should be drawn in favor of Finance & Accounts Officer, KBCNMU, Jalgaon

- 3) **Payment:** 100% payment after satisfactory supply and Installation & technical committee report received from the technical committee. Within 30 days from the date of supply No part payment will be made. Rates quoted should be inclusive of GST.
- 4) **Completion Period:** - The supply as per purchase order should be completed within 4 to 6 weeks from the date of receipt of the purchase order. If the bidder fails to complete the installation within the period, the University Administrative Office will be entitled to recover penalty as liquidated damages @ 0.5% of total value of invoice each week or parts thereof during which the delay of such store's delays subject to maximum in limit of 5%.
- 5) After supply, the tenderer should install and commission all the **Rota Evaporator** within the stipulated time given in Purchase Order (P.O.). Delay beyond this period will attract penalty at the rate of 0.1% of the purchase order cost per day of delay subject to maximum 5% of the purchase order cost and it would be deducted from subsequent payment. The university reserves the right, without liability, to cancel the order in such cases and it will be free to place an order on any other party.
- 6) **Rota Evaporator** covered in this tender may be inspected and tested by the University authority/engineer if deemed necessary by the University, the successful tenderer shall provide without charge, all reasonable facilities and assistance for such inspection and test.
- 7) **Terms of Delivery:** - All material must be supplied within **04 - 06 weeks** from the date of receipt of purchase order F.O.R. K.B.C.N.M.U. (**School of Chemical Sciences**)

- 8) **Performance Bank Guarantee:** The Successful bidder will have to submit the performance Bank guarantee along with invoice equivalent to 5% of total value of invoice towards performance bank guarantee for the period of 60 days beyond warranty period
- 9) **Rates mentioned in commercial bid must be inclusive of GST.**
- 10) Tender is being called in two envelopes system. i.e. the technical bid and commercial bid. The technical bid comprises part-I details of the tenderer, Part-II Technical bid and Part III general and commercial conditions of the tender. The Commercial bids comprise Part IV. The tenderer must submit both the bids in separate envelopes.
- 11) Copies of shop Act Registration, GST /Shop Act, PAN Registration, Copies of Income Tax return filed during last three financial years, annual turnover etc. should be enclosed along with part-I.
- 12) The Tenderer must be submitting his offer in two separate envelopes A-B envelope-A will contain part I, II, III and Envelope –B will contain part IV both the envelopes must be super cried as **“Tender for Supply and Installation of Rota Evaporator.”**
- 13) The University reserves the right to accept or reject any or all the tenders from any or all the parties without assigning reason thereof.
- 14) Cancellation of work/ supply / purchase order: University reserves the right to cancel the work order in case tenderer fails to supply and installation of Rota Evaporator. Within the stipulated time given in the work order. The University reserves the right to go for next lowest tenderer or other appropriate action will be taken.
- 15) If due to the above-mentioned reason work order is canceled, earnest money and security deposit shall be forfeited and also the tender may be allotted to the next lowest tender or the University have kept reserves the right to take any other appropriate decision including legal action against the bidder to whom work order was given.  
Tenderer must submit cost of tender documents and EMD only through INTERNET BANKING
- 16) **Warranty:** The bidder should clearly mention the period of standard warranty of Rota Evaporator. (as mentioned in technical specifications)
- 17) **Safety & Security:** - Safety & Security of all the equipment material shall be responsibility of the vendor till the completion of work as per purchase order. Tender offer must be valid for a period of minimum 120 days from the date of opening of commercial / financial bid. Any offer failing short of the validity period is liable for rejection.
- 18) **Installation and Commissioning: Rota Evaporator** must be installed and commissioned at **School of Chemical Sciences, Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon.** The required accessories if any& cables should be provided.
- 19) **Jurisdiction:** The courts at Jalgaon alone will have the jurisdiction to try any Matter, dispute or reference between parties arising out of this tender/ contract. It is specifically agreed that no court outside and other than Jalgaon court shall have Jurisdiction in the matter.

- 23) Tender received after due date and time will not be considered whatever may be the reason. Therefore, in case tender are sent by post / speed post courier etc., it shall be responsibility of the tenderer to ensure that they are received before due date and closing office hours.
- 24) The rates without any corrections or overwriting should be quoted for each individual item separately. Any overwriting or rewriting should be duly countersigned.
- 25) The decision of the University regarding this will be final and shall be binding on tenderer. The University reserves the right to accept or reject the entire tender.

- 26) The tenderer must have a minimum turnover of Rs. 35.00 Lac or more for each of the past 03 financial years (2021-2022, 2022-2023, 2023-2024)
- 27) The successful bidder should submit a printed original bill of GST mentioning the University's GST No.27AAAJN0465A1ZL while submitting the payment proof of payment of the GST amount in the bill will be required to be submitted to the government the payment will be made after 30 days after the recommendation of concern department (if required technical committee) regarding the satisfactory performance of work.
- 28) The Venders blacklisted by the University are not eligible for submitting the tender. If they do so their tender will not be considered.
- 29) The last date for submission of tender shall be **13 /09/2024** during office hrs. (10.00 am to 5.40 pm) at Office of the Finance and Accounts Officer, KBCNMU, Jalgaon.
