- 3) Payment : 100% payment after satisfactory supply and Installation & technical committee report received from the technical opinion of expert. Within 30 days from the date of supply. No part payment will be made. Rates quoted should be inclusive of GST.
- 4) **Delivery Period** :- All material must be supplied within **04 weeks** from the date of receipt of purchase order.
- 5) **Terms of Delivery** : F.O.R. KNOWLEDGE RESOURCE CENTER at K.B.C.N.M.U. Jalgaon
- 6) **Security Deposit** : The successful tenderer will have to give security deposit to the extent of 5% of total order value. The amount of security deposit without any interest there on will be returned to the tender after satisfactory completion of work.
