4	The Registrar	As prescribed under Section 14 of the Maharashtra Public Universities Act, 2016
5	The Dean	As prescribed under Section 16 of the Maharashtra Public Universities Act, 2016
6	The Director, Board of Examinations and Evaluation	As prescribed under Section 17 of the Maharashtra Public Universities Act, 2016
7	The Finance and Accounts Officer	As prescribed under Section 18 of the Maharashtra Public Universities Act, 2016 (Acting)
8	The Director of Sub-campus	As prescribed under Section 19 of the Maharashtra Public Universities Act, 2016 (Vacant)
9	The Director of Innovation, Incubation and Linkages	As prescribed under Section 20 of the Maharashtra Public Universities Act, 2016 (Vacant)

12	The Director of Students' Development	As prescribed under Section 23 (a) (3) of the Maharashtra Public Universities Act, 2016
13	The Director of National Service Scheme	As prescribed under Section 23 (b) (3) of the Maharashtra Public Universities Act, 2016
14	The Director of Sports and Physical Education	As prescribed under Section 24 (5) of the Maharashtra Public Universities Act, 2016 (Acting)
15	Such other officers in the service of the university as may be prescribed by Statutes and also duties Prescribed by superior or Registrar from time to time.	All salaried officers, members of the authorities, committees or bodies, teachers of the university and other employees of the university, shall be deemed to be public servants within the meaning of section 21 of the Indian Penal Code.
