CORRIGENDUM TO NOTICE INVITING EXPRESSION OF INTEREST

Vide EOI Notice No. NMUJ/8/____/2025 dated 01.12.2025, Kavayitri Bahinabai Chaudhari North Maharashtra University (KBC NMU), Jalgaon invited sealed **Expression of Interest (EOI)** from reputed and eligible **Chartered Accountant (CA) / Cost Accountant (CMA/ICWA)** for the work of:

“Physical Verification of Fixed Assets and Updating of Fixed Asset Register in SAP, including Restoration of Asset Values based on Revised Useful Life at KBC NMU, Jalgaon.”

In this connection, the following **Corrigendum** is hereby issued for information and necessary compliance by all interested bidders.

1. Tender Handling Fee and Earnest Money Deposit (EMD)

It is hereby clarified that the **Tender Handling Fee** and **Earnest Money Deposit (EMD)**, as referred to in **Sr. No. 1 and Sr. No. 2** under ‘Critical Dates and Information’, shall be paid as under:

2. Minimum Fees of Tender Work

It is hereby notified that the **Minimum Fees of the Tender Work** shall be:

Rs. 3.00 Lakhs (Rupees Three Lakhs Only) plus applicable GST.

Financial bids quoting fees **below the above minimum amount shall not be considered.**

3. Amendment in Scope of Work – Clause 3 (B)


Point No. 2 under Sub-Clause (B) – “Restoration of Value & Assessment of Useful Life” in Clause No. 3 (Scope of Work) shall be read and construed as under:

“Calculate the revised depreciation as per the provisions of the Income Tax Act and restore assets.”

Except for the above modifications at **Sr. No. 1 to 3, all other terms, conditions, scope of work, eligibility criteria, dates, and provisions of the original EOI Notice dated 01.12.2025 shall remain unchanged and binding.**
