- 2) Payment : 100% payment after satisfactory supply and Installation & technical committee report received from the technical committee. Within 30 days from the date of supply No part payment will be made. Rates quoted should be inclusive of GST.
- 3) **Delivery Period** :- All material must be supplied within **02-03 weeks** from the date of receipt of purchase order.
- 4) **Terms of Delivery** : F.O.R. University Campus at K.B.C.N.M.U. Jalgaon
- 6) **Security Deposit** : The successful tenderer will have to give security deposit to the extent of 5% of total purchase order value. The amount of security deposit without any interest and will be returned after completion of warranty period.
