- 3) Payment: 100% payment after satisfactory supply and Installation & technical committee report received from the technical committee. Within 30 days from the date of supply No part payment will be made. Rates quoted should be inclusive of GST.
  - 4) <u>Terms of Delivery</u>: F.O.R: -The rates quoted should be F.O.R the University Campus (delivery to be given to University Institute of Chemical Technology of K.B.C.N.M.U., Jalgaon. - 21) Tender received after due date and time will not be considered whatever may be the reason, therefore. In case tender are sent by post / speed post courier etc. It shall be responsibility of the tenderer to ensure that they are received before due date and closing office hours.

- 22) The rates without any corrections or overwriting should be quoted for each individual item separately. Any overwriting or rewriting should be duly countersigned.
- 23) The decision of the University regarding this will be final and shall be binding on Tenderer. The University reserves the right to accept or reject the entire tender.
