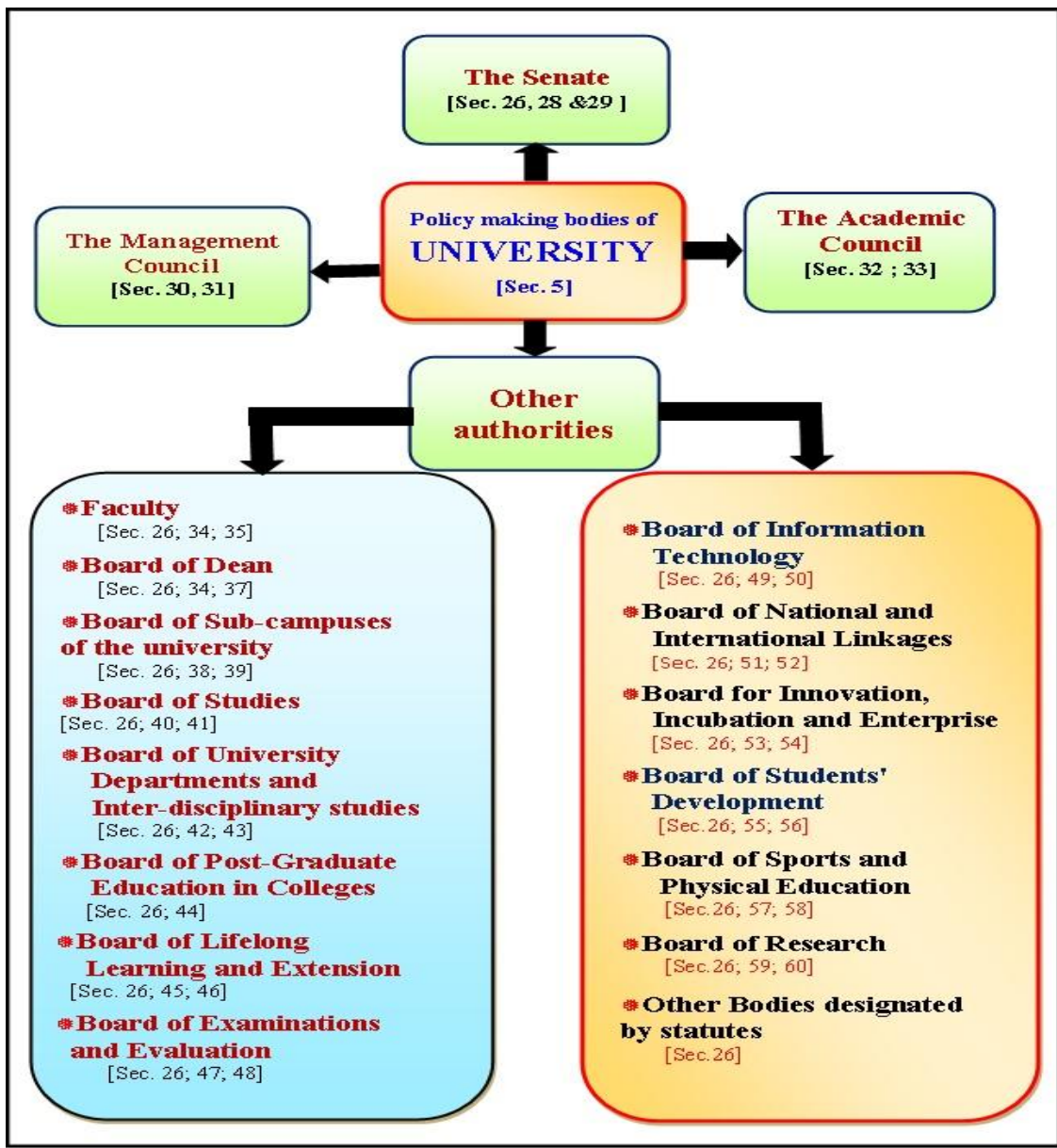

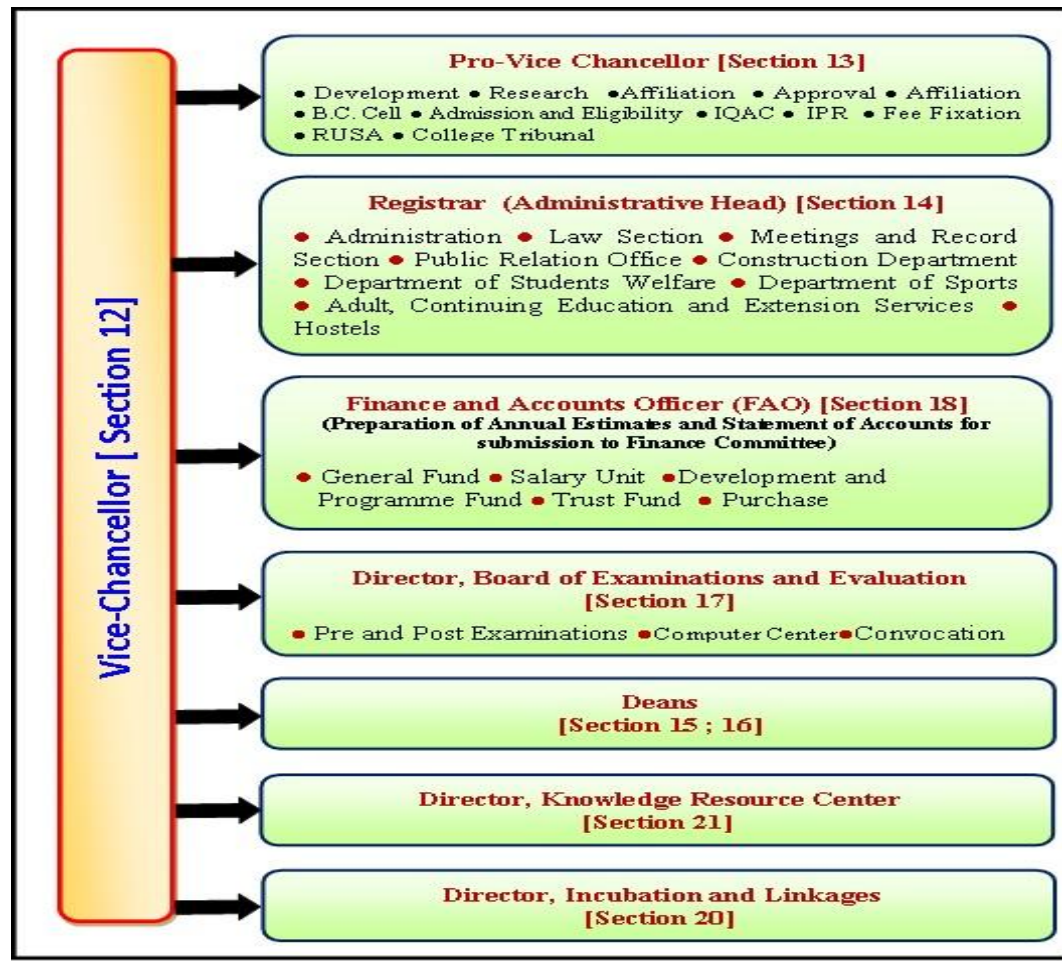
The functioning of the institutional bodies

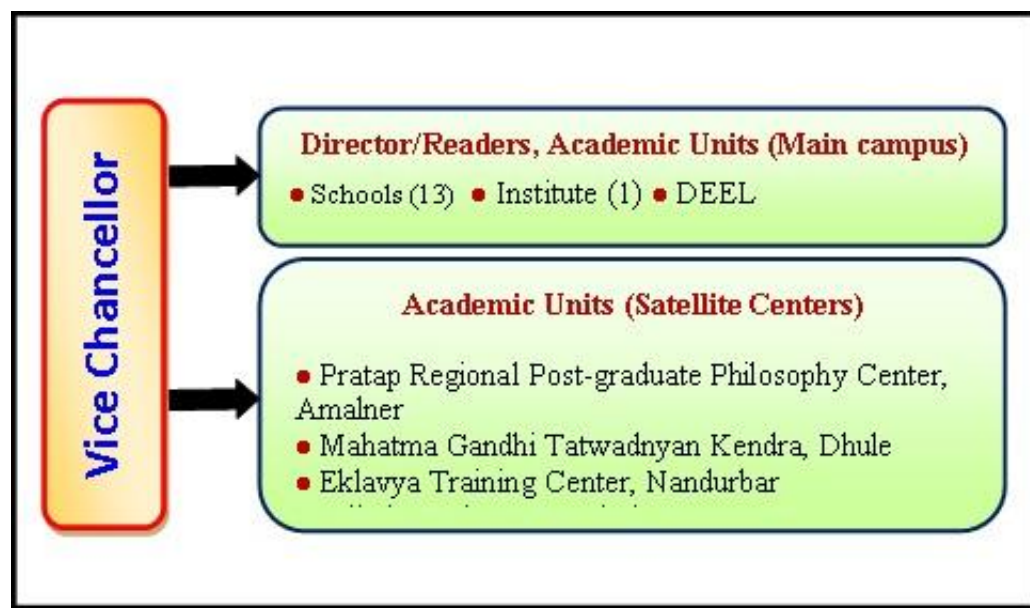
- **The organization profile of various authorities of the University.**
