- Qualifications as per UGC/AICTE and adopted by Maharashtra State Government vide GR dated 8th March 2019/11th September, 2019.

For - **Chemical Sciences : (As per UGC rules)**

ASPCS-1 (Physical Chemistry), **ASPCS-2** (In-organic Chemistry)

ASPCS-3 (Organic Chemistry)

- 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET

Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

OR

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS) ;
- (ii) the Times Higher Education (THE) or
- (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

NOTES, INSTRUCTIONS, TERMS AND CONDITIONS :

Candidates must read all the instructions before filling online application form in the prescribed "Format of Application" from the University website www.nmu.ac.in Candidates must ensure that no column is wrongly filled in application form as the information furnished therein will be used for deciding the eligibility and suitability of the candidates for being called for the interview and or selection. Application not filled in correctly, incomplete or not as per instruction are liable to be rejected and the responsibility of such rejection will be on the candidate himself/herself.


1. A relaxation of 5% marks be provided (from 55% to 50% of the marks) to the Ph.D.Degree holders who have obtained their Master's Degree prior to 19th September, 1991.
2. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized University, at the Master's level shall also be considered valid.
3. A relaxation of 5% shall be allowed at the Bachelor's as well as the Masters' level for the candidates belonging to scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non creamy Layer) /Differently abled ((a) Blindness and low vision: (b) Deaf and Hard of hearing: (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy: (d) Autism, intellectual disability, specific learning disability and mental illness. Multiple disabilities from amongst person under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
4. Reservation policy for disabled persons will be as per General Administration Resolution dated 29.05.2019.
5. Women's Reservation will be applicable as per Government Resolution dated 25th May, 2001. Non-Creamy Layer certificate is not essential.
6. Non-Creamy Layer Certificate for the candidate belonging to the DT-A, NT-B, NT-C, NT-D, OBC and SBC categories, as per Govt. of Maharashtra Resolution dated 16th December, 2017, issued by the competent authority valid till the date 31.03.2024.
7. The candidate applying for the post of reserved categories should submit caste certificate, /cast validity certificate issued by competent authority. The appointment of the selected candidate on respective reserved category shall be made only after the receipt of Caste Validity Certificate in the light of Govt. of Maharashtra G. R. No. CBC 10/2010/Pr. Kr.47/mavk-5 dated 26.03.2010.
8. The minimum period of probation of a teacher shall be one year, extendable by maximum period of one more year in case of unsatisfactory performance.
9. Weightage shall be given to the applicants who have published work of high quality and who have succeeded in bringing funds by submitting research projects to various funding agencies such as UGC/ CSIR/ DST/DBT/TWAS/ ISSR/AICTE etc.
10. Candidate belonging to specific reserved category from Maharashtra State alone shall be considered for reserved post and they are required to submit Caste Validity certificate at the time of joining.



11. Candidates from reserved category, who are domiciled outside the Maharashtra State will be treated as Open category candidates as per Govt. G.R. No. CBC-1290/23116/pra.kra.378/avaka-5 dated 24.08.95.
12. Candidates having cleared State Eligibility Test (SET) from the State other than Maharashtra State shall not be considered for appointment.
13. As per provision contained in State Govt. Notification No. SRV.2000/ CR(17/2000)/XII dated 28th March, 2005, issued by General Administration Department, Mantralaya, Mumbai, candidates must submit the prescribed declaration of the small family as one of the essential qualifications for recruitment, the prescribed proforma is attached herewith as **Appendix B**.
14. **The University Authority reserves its right, to fill up or not to fill up the posts, to modify/ alter/cancel the advertisement.**
15. **In the process of selection of Assistant Professor, the academic score as specified in Appendix II (Table 3A) of the G.R. Dtd. 8 March, 2019 shall be considered for short-listing of the candidates. No correspondence will be made with applicants who are not short-listed/not call for interview.**
16. If the Candidate appointed in the University services after 1 Nov.2005 would be covered under New "Defined Contribution Pension Scheme" and the existing pension scheme (i.e. Maharashtra Civil Services (Pension) Rules, 1982 and Maharashtra Civil Services (Commutation Pension) Rules 1984) and General Provident Fund Scheme will not be applicable as per Government Resolution **SENIVE/1005/127/SEVA-4, dated 8 Nov, 2005**. This rule shall not be applicable to the candidate who is already working in pensionable establishment, subject to the conditions mentioned in the G.R. No. CPS-1006/87/SER-4 dt.12 Jan., 2007 & 24 Feb., 2009.
17. The candidates who are already in service should apply through proper channel and bring NOC from the present employer if changed at the time of Interview, otherwise protection of pay and previous services could not be considered. They should furnish all the relevant information regarding their present service, legal proceeding of complaint, court cases, criminal cases, disciplinary actions, if any , pending in r/o his/her existing appointment /services. The candidate furnishing incorrect or false information shall stand disqualified. Any changes in this information as and when occurred after the submission of application from till the completion of recruitment process should be brought to the notice of the University, failing which the University reserves the right to cancel the candidature and to debar him/her from all selections.
18. The University shall verify the antecedents or documents submitted by a candidate, at any time, at the time of appointment or during the tenure of service. In case of fake documents, clandestine antecedents or suppression of information, service in the University shall be terminated.
19. All disputes arising out of this advertisement are subject to Jalgaon Jurisdiction.
20. Selected candidate will have to submit the prescribed attestation forms.
21. The age of retirement shall be as prescribed by the State Government.
22. Canvassing directly or indirectly will be treated as disqualification.
23. Knowledge of Marathi Language is desirable for all posts
24. No TA/DA will be paid either for attending the interview or for joining the post.
25. Applicant who wishes to be considered for more than one post should apply separately for each post.



26. Mere possession of minimum qualifications does not confer any right to be called for interview and /or selection.
27. A candidate furnishing incorrect or false information shall stand disqualified at any stage.
28. Applications received after the last date and/or not submitted through proper channel and/ or incomplete application will not be considered.

Applicants will be required to enclose self attested clean photo copy of certificates of their educational qualifications, date of birth, educational qualifications, caste certificate, non-creamy layer certificate, caste validity certificate (if obtained) experience, research experience etc. to each hard copy.
32. Applicants are advised to submit the two hard copies of application to the University well in advance, without waiting till the last date, to avoid postal delay or any other unforeseen problems. The University will not be responsible for any postal delay at any time.
33. Application received via **E-mail or Fax** or through any **electronics mode** will not be accepted.

35. Application fee of Rs.500/- (for open category) (non-refundable) and Rs.250/- (for candidates belongings to reserved category) (non-refundable) should be paid by online mode only.
